

## **General Terms of the Morris Area Freewheelers (MAFW)**

### **Member Privacy Policy – May 2, 2012**

Our Club is committed to protecting your personal information when you are using our services from us. We want our services to be a safe and enjoyable environment for our users. This Privacy Policy relates to our use of any personal information you provide to us by any means.

In order to provide you with the full range of services, we are sometimes required to collect information about you.

#### **This privacy policy explains the following:**

- What information MAFW may collect about you;
- How MAFW will use information we collect about you;
- Whether MAFW will disclose your details to anyone else;
- The use of cookies on the MAFW website.

As set out above, MAFW are committed to safeguarding your personal information. Whenever you provide such information, we are legally obliged to use your information in line with all laws concerning the protection of personal information, including the Data Protection Act 1998 (these laws are referred to collectively in this Privacy Policy as "data protection laws").

#### **1) Information members provide MAFW.**

- We may collect and store any personal information that you provide to us for the purpose of subscribing to any services from MAFW, including e-mail address, name, phone number or other information listed in your website member profile (accessed via "My Profile").

#### **2) MAFW will use your personal information for several reasons including the following:**

- For website administration purposes, which means that MAFW may contact you for reasons related to the service you have signed up for, (For example; to notify you that a particular ride has been cancelled).
- To personalize the way that content on the MAFW website is presented to you.
- To allow us to deal with any inquiries and complaints made by or about you relating to the MAFW website.

-We may disclose information about you to any of our Officers or any other club member whenever it is reasonably necessary for the smooth administration of the MAFW club or to handle personal emergencies.

-To the extent that we are required to do so by the laws of the states and the US federal government.

-We will not sell or provide your information to third parties.

### **3) The MAFW may use cookies.**

-Cookies, are parcels of text sent by a server to a Web client (usually the browser of a computer accessing a website) and then sent back unchanged by the local computer each time it accesses that server. Every time the user visits the webpage the cookie can be used to help identify them.

-Any advertisers on our site with a link to their site may place cookies on your local computer if you access that link. This subject is also covered under item #7 below.

-Most modern browsers allow users to decide whether to accept cookies, but rejection makes some websites unusable.

### **4) The MAFW organization takes reasonable technical precautions to prevent the loss or misuse of your personal information.**

-We will store all personal information on secure servers. The Internet itself however is relatively insecure and as such we cannot guarantee the security of any data sent over the Internet.

-You are responsible for keeping your password secure. We will never ask you for your password via email or any other means. Any attempt of this should be treated as suspicious. Upon request, we can reset your password if you send an email to [membership@mafw.org](mailto:membership@mafw.org).

### **5) Changes to this MAFW Privacy Policy**

-We may update this Privacy Policy by posting new versions on the website.

-We reserve the right to notify you by email of any changes to this Privacy Policy.

### **6) Information MAFW holds about a MAFW members**

-Under the Data Protection Act you have the right to request a copy of the personal information that we hold about you and to have any inaccuracies corrected. We will require you to prove your identity to our reasonable satisfaction. We will also use reasonable efforts to supply, correct or delete personal information about you in our files.

#### **7) Third party websites external to MAFW**

-The MAFW website may contain hyperlinks to websites owned and operated by third parties. These third party websites have their own privacy policies, including cookies, and we urge you to review them. Those policies will govern the use of personal information you submit or are collected by cookies while visiting these websites. The MAFW organization accepts no responsibility or liability for the privacy practices of such third party websites and your use of such websites is at your own risk.
